## MAIN FEATURES OF CROP INSURANCE PUNJAB

- 1. 100% premium subsidy to insurance company for small and marginalized farmers having landholding of less than 5 acres. However, GoPb will provide 50% premium subsidy to farmers having landholding of >5 to 25 acres.
- 2. Started in Kharif 2018 with 4 districts (Sheikhupura, Sahiwal, Lodhran & R Y Khan) on pilot basis. 16,750 insurance policies were issued to farmers of Cotton & Rice. The sum insured was Rs. 50,000 for E-Credit borrowers and Rs. 20,000 for (Crop Loan Insurance Scheme) CLIS borrowers. During Pilot only loanee farmers were eligible. Total premium paid Rs. 41.60 million. Claims of Rs. 32.7 million were paid to 1,986 farmers of ChichaWatni Tehsil of Sahiwal District.
- **3.** In Rabi 2018-19, five (5) more districts were added (Faisalabad, Multan, Muzaffargarh, Narrowal & Rajanpur). **41,375 farmers** of Wheat crop were insured against the premium subsidy of **Rs. 54 million**. From this season onward, tenant loanee farmers were also included.
- 4. In Kharif 2019, nine (9) more districts were included (Bhakkar, DG Khan, Kasur, Khanewal, Layyah, MB Din, Bahawalnagar, Okara & Bahawalpur). Total of 226,832 farmers (cotton & Rice) in 18 selected districts are insured against the premium subsidy of Rs. 400.49 million. Claims of Rs. 98.20 million were paid to 4,958 farmers of Rajanpur & Kabirwala Tehsils of Rajanpur & Khanewal Districts respectively. From this season, non-loanee farmers were made eligible as well.
- 5. For Kharif 2020 season, 254,482 farmers (cotton & Rice) in 18 selected districts are insured against the premium subsidy of Rs. 482.90 million on the basis of "NO CLAIM BONUS REGIME" that means in case of no yield loss or losses within the premium subsidy payment, 95% of the remaining payment will be returned back to Government Treasury. In other words, the absolute premium subsidy paid is Rs. 116.0 million. From Rabi 2020-21, nine (9) more districts will be included namely Vehari, Khushab, Jhang, Chiniot, Pakpattan, Toba Tek Singh, Sargodha, Mianwali & Hafiz-Abad.
